May – Ethics Institute Director Sonu Bedi

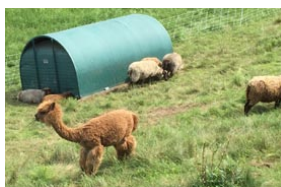
Our Annual Seminar is planned for Feb. 17th and we will be assembling representatives from various conservation and outdoor activities programs in the Upper Valley.

Our Visit to Sweetland Farm in Vermont on August 6

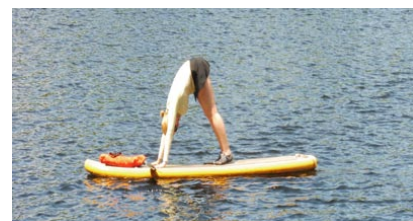

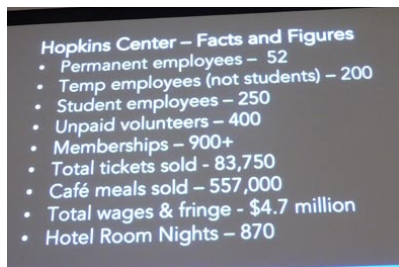

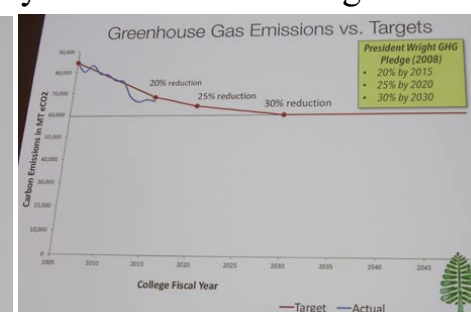
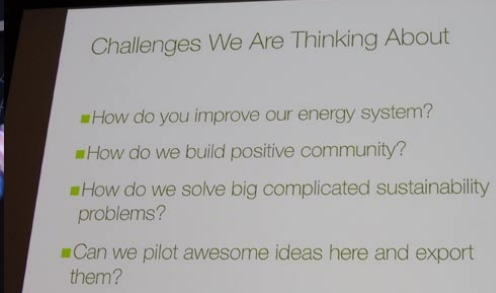
